## Councilman Reilly Proposes Landfill Elimination

Following on the recommendation of the Small Area Plan for South County (SCSAP) and the looming threat of Fly Ash dumping, County Councilman Ed Reilly will introduce legislation to strike language in the county zoning code that allows rubble landfills in RA zones.

Existing county zoning allows landfills in much of the county's rural area under a "special exception" provision. Once believed to be a benign technique for restoration of sand and gravel mines. We now know that they are heavy-industrial operations catering to an inter-state market. The materials dumped are dangerous to our air and water; requiring sophisticated liners & leachate collection systems in hopes of protecting the ground-water that supplies drinking water to nearby residents. Noxious gases will contaminate the nearby air as materials in the dump decompose.

We have discovered the value in our rural, agricultural open space. We have spent tens of millions of public dollars to protect it. We have created "Rural Legacy" zones. Designated

scenic/historic roads. Mounted expensive programs to protect and preserve farming operations in our rural areas. We now know this is not the cheap, out-of-the-way place to dump waste from other jurisdictions.

Congratulations to Councilman Reilly for leading a long over-due effort to correct this serious threat to the health and quality of life of South County residents.

### CEPA begins review of PST Landfill Monitoring Program

Earlier this year the Chesapeake Environmental Protection Association (CEPA) received a grant from a fund established to address adverse impacts from the PST landfill on Sands Rd in Harwood.

PST operated between December 1992 and July 1, 2001. Between 1997-2001 PST received almost 2 million tons of waste. Over 80% (1,548,062 tons) came from generators outside of Anne Arundel County. To grasp the scale of this operation, consider that during the same period the Millersville landfill received 509,068 tons. PST received 4 times as much waste as Millersville. At its peak year, 1997, PST received 7½ times that of Millersville. The landfill operated without a liner and leachate collection system.

CEPA will secure independent professional analysis of ground water monitoring procedures and reports and, if necessary, challenge decisions and conclusions by regulatory agencies regarding the need to continue monitoring the safety of drinking water wells in the vicinity of the PST landfill.

## S.E.R.C.

### What is it?

SERC is the Smithsonian Environmental Research Center on Contees Wharf Road in Harwood. It includes nearly 3,000 acres of wildlife conservation area and 14 miles of undeveloped shoreline on the Rhode and West Rivers. Since its establishment in 1964, SERC has been a leader in investigating such issues as elevated carbon dioxide in the atmosphere, sediment run off into the Chesapeake Bay, the response of fish to elevated levels of mercury, the effect of invasive species such as the Chinese mitten crab, and the development of models to assess overall wetland health.

On August 3, 2008, HCA members were treated to a personal introduction to the center presented by Dr. Anson Hines. A slide show outlining the many research projects currently under way at SERC was followed by a tour of the newest land acquisition, the Contee Farm.

SERC offers monthly activities for children, school groups, and adults. These include guided hikes, canoe trips, evening lectures, story hours, and home school programs. There are more than three miles of wooded trails including the Java history trail. There is also a boat ramp for launching canoes and kayaks. For more information, access SERC's website:

## HCA Supports Southern High College and Career Center

## Be Good to the Bay

Cool season grasses (fescue, bluegrass, ryegrass) should be fertilized primarily in the late summer or early fall to help the grass recover from summer stresses. Nitrogen uptake in the fall is at its peak for cool season grasses. Warm season grasses, such as zoysia grass and Bermuda grass, should be fertilized in the early summer because that is when they are growing most actively. Grass clippings supply free fertilizer and will not cause thatch problems. If clippings are too long, they may clump. Rake up excessive clippings for mulch or compost and mow more frequently. If you leave clippings on the lawn for two years or longer, you may be able to lower the amount of nitrogen fertilizer you use by 25 percent or more.

## **The Target Mall in Wayson's Corner – An Expensive Planning Mistake**

County Executive Leopold has been criticized for his handling of the Target Mall in Wayson's Corner. Such criticism ignores the circumstances leading up to the County's use of Maryland Project Open Space funds to buy and prevent development of approximately 30 acres of commercial land in Wayson's corner.

Accusations that the project needlessly wasted millions of dollars of public money are accurate but blaming John Leopold is incorrect. By the time Mr. Leopold became County Executive the Target Mall was moving rapidly toward becoming a reality. His 11<sup>th</sup> hour rescue mission responded to overwhelming community demand and protected a treasured national wetland.

That this project ever got to this stage was a blunder of his predecessor. The Small Area Plan for South County, approved unanimously by the County Council and the County Executive in 2001, correctly cited the vulnerability of Wayson's Corner to improper development. It called for a "viable rural commercial area that meets the needs of South County." It specifically called on the County to "Recognize that strip malls, national franchises, and up-zoning are inconsistent with the rural character of South County" and went so far as to propose a concept plan for appropriate development.

The failure of the previous administration to act on the wise advice of area citizens to assure appropriate commercial use of Wayson's Corner led to a costly, last minute solution.

There is an important lesson to be learned from this case. Active citizen participation in land-use planning is vital. Citizen input is valuable and must not be ignored. As we move into a revision of the County General Development Plan, County Executive Leopold must make sure that citizen's voices are both heard and heeded.

## **The General Development Plan (GDP) for Anne Arundel County is being revised. Why should you care?**

The official statement about the GDP from the County website is as follows, "Anne Arundel County's General Development Plan, or GDP, is a comprehensive land use plan prepared in compliance with State requirements and guidelines. The Plan is a policy document that is formally adopted by the County Council. It establishes policies and recommendations to guide land use decisions over the 10 to 20 year planning horizon. The Plan is used by the County in making decisions about growth and development, land preservation, resource protection, and the provision of infrastructure and services."

In actual practice the GDP has proven to be largely ineffective in determining development policies in Anne Arundel County. A quick review of the current Small Area Plan for South County <http://www.aacounty.org/PlanZone/SAP/SouthCounty.cfm> shows numerous unmet goals. i.e.: Barely 50% of agricultural land preservation goal met; Wayson's Corner zoning overlay not accomplished; elimination of special exception for landfills not enacted; and most critical – no appointment of a monitoring committee to measure progress.

### **So why bother to expect a meaningful Plan this time?**

**During the campaign for County Executive, John Leopold spoke frequently about his priority for a strong, citizen led GDP, "In my administration the General Development Plan will be adhered to, and master plans and small area plans will be respected. It is imperative that the public be given ample opportunity for input in the revision of the General Development Plan."**

## Rt 2 Improvements Some Planned – Some Stalled

**SHA plans to resurface MD 2 this Fall.** At the completion of the project, the centerline rumble strips will be reapplied and the limits will be extended from MD 214 all the way down into Calvert County to the MD 2/MD 4 split. With the resurfacing of the road, this will also address the friction problem that is occurring at Polling House.

**MD 408 & MD 259 (Greenock Road).** The speed limit sign within the curve has been relocated so that it does not confuse motorists. There is an advisory speed displayed along with the curve warning sign advising motorists **to slow down through the curve.**

**MD 2 and Harwood Drive:** The northbound acceleration lane and the southbound left turn bypass lane are on the corridor's wish list, but there is no additional funding to move them forward at this time.

**MD 2 and Harwood Road:** Designing a change in the location of the signal ahead flashers so that they are further back from the intersection. More advance warning is necessary due to the long queues at the signal, and the horizontal curve in the road.

**MD 2 at Birdsville** Southbound turn lane- Ready to advertise this project for construction in January 2009 for a spring construction start. Awaiting final approval of the funding.

**MD 2 at MD 255, MD 2 at MD 256** - These two intersections will be advertised as a single project. They are ready to begin in the spring of 2009. Awaiting final construction funding approval.

**MD 2 at MD 423** Turn lanes-. This project is not yet funded for construction. Design will continue this fall.

**Lothian Roundabout** Additional lanes- This project is still in design. Construction funding has not been approved yet.

## Rumble Strips - Perseverance Pays

Surely everyone has noticed the new rumble strips on Rt 2 south of Southern High School. The strips are intended to provide a warning to drivers crossing the centerline. Centerline crossovers have caused several of the most serious recent crashes.

The placement of the strips is the result of a good idea and long-term perseverance by John Aylor, a faculty member at Southern High School. Ten years ago, in the Fall of 1998, Mr. Aylor and Ms. Deloris Jerry wrote to the Maryland State Highway Adm. (SHA) after a crossover crash killed five people at Rt 2 and Mary's Mount Rd.

Mr. Aylor and Ms. Jerry urged SHA to install rumble strips. Although the request was denied, Mr. Aylor continued to advocate for the strips. Now ten years later, following more meetings and letters combined with leadership from the Harwood Civic Association, the strips are in place and will be installed all the way from Central Ave. to the Calvert County line!

## MD Rt 2 Accident Statistics

Most residents of Harwood have an ominous sense of the growing traffic and growing danger associated with travel on Rt 2. The HCA has hosted several community forums on the subject and has worked with state & local officials seeking improvements. Some improvements have been made and others are in the pipeline (see related project list). Following is a summary of recent traffic accident statistics for the area.

According to Anne Arundel County Police records\*, there have been 246 motor vehicle accidents along Md Rt 2 between Md Rt 214 (Central Ave) and the traffic circle in Lothian between 1/1/05 and 6/30/2008. Almost 20% of these accidents (47 accidents) resulted in personal injury or fatalities (2).
