Letter to County Executive Leopold

In a letter sent to County Executive John Leopold on August 6, 2007, The Harwood Civic Association joined with the Lothian Civic Association and the Friends of Jug Bay in stressing the importance of agricultural preservation and offered their help in making Anne Arundel County's preservation programs successful. As can be seen in the attached letter and chart, our county has one of the poorer records for preserving important lands.

Dear County Executive Leopold:

On behalf of the Harwood Civic Association (HCA), hearty congratulations on your recent actions to protect agricultural and forest lands in Anne Arundel County. Your judgments and solutions for the Wayson's Corner Target site, the Naval Academy Dairy property, and the Crofton Wal-Mart location demonstrate a much-needed instinct to aggressively solve problems. While dramatic and necessary, these "rescues" demonstrate the vulnerability of much of the County's most important lands to undesirable sprawl development.

In that regard, HCA, The Lothian Civic Association and Friends of Jug Bay Wetland Sanctuary strongly believe that there is an urgent need to aggressively expand Anne Arundel County's ongoing land preservation programs. We want to help in the achievement of improvements!

In an effort to better understand the relative success of Ag/Forest land preservation programs in Anne Arundel County we have collected information on similar programs in nearby jurisdictions. The attached table shows comparative data for Anne Arundel County and four nearby jurisdictions. While each jurisdiction has unique characteristics, it seems reasonable to conclude from this data that efforts in Anne Arundel County have been under-resourced, thus leading to our County's under-performance in comparison with the other jurisdictions. Your leadership, however, has signaled a positive change.

We hope to be able to offer useful advice and support in what we regard as an urgent need to protect these lands in the face of mounting development pressures and escalating prices that may limit the effect of publicly financed preservation efforts. Recognizing current funding challenges, we are prepared to rally volunteers to provide assistance to your staff. Specifically, we believe community support can contribute to improved understanding of the benefits of Ag/Forest land preservation to farmers, landowners & the general public. For example, how many of the wealthy landowners in South County know that 2007 is such an important year (in terms of the best tax breaks) to donate conservation easements? This opportunity needs to be aggressively marketed to property owners and their financial/tax advisors.

We would like the opportunity to meet with you to discuss our ideas and set an action plan for improvement. I will contact your office shortly to make the arrangements.

HEALTH OF THE WEST RIVER WATERSHED 2007

The West River seems to be on the borderline between healthy and unhealthy. Water clarity is bad. Average DO (dissolved oxygen) measured at the bottom by me and the Riverkeeper is not so bad and DO measured continuously by DNR at 1 foot is much better. Our river had an average score of 51 out of 100 for the last 3 years. In any academic setting, that is an F (A=90-100, B=80-90, C=70-80, D=60-70). Everything seems to revolve around the lack of plants on the bottom of the river. The sediment from runoff with its bacteria, phosphorus and nitrogen has created a poisonous sludge that is probably suffocating the bottom of the river. Underwater grasses increased enormously over what was recorded by the Virginia Institute of Marine Science (VIMS) in 2006 but it was mostly because their fly over was made late in the year and no one saw or recorded the brief flash of spring annual Horn Pondweed. It is promising that there is brief life in the river bottom but I don't know what it means. Somehow we need to get the perennial grasses to return to our river. The oyster project POWeR is doing well and needs all the support we can give it. But it is difficult to believe that oysters will ever be able to clarify the water in the Bay as they once did. We certainly need to do everything we can to prevent more sediment from getting into the river. It would be fantastic if we could find a way to make the bottom sediment become a resource. Maybe we could compress it enough and generate heat that would turn it into a solid block for building a solid bottom. The health hazard posed by bacteria and other chemicals that we aren't measuring need to be addressed soon.

South County Park and Recreation Areas

Beaches and Waterfront

A very special facility of Anne Arundel County Department of Recreation and Parks is Mayo Beach Park, located at the mouth of the South River on the Chesapeake Bay (Mayo). The park features a sandy beach, shaded picnic areas, pavilion, playing fields and clubhouse. Mayo Beach Park is open to the public on designated days during summer weekends (Sundays in July in 2007). The park is also available for rental use on a permit basis to civic and nonprofit organizations, wedding, receptions, cultural exhibits, company picnics and family reunions. Beverly Triton Park is a rustic, undeveloped waterfront park on the Chesapeake Bay in Mayo. It is open by permit only for walk-in visits. Beverly Triton boasts a sandy beach and natural walking trails. To request a monthly permit, please contact Jeff Mauck at 410-222-1520.

Anne Arundel County also offers Chesapeake beach experiences on the West River at Galesville Pier; at Carr's Wharf Pier on the South River; on the Bay at Holland Point Park (Friendship); and at Rockhold Creek at Deale Pier.

Jug Bay Wetlands Sanctuary and the Parris Glendenning Nature Preserve at Jug Bay (Lothian) comprise a wonderful natural area stretching along the Patuxent River. The park is open Wednesdays, Saturdays and Sundays (9:00am – 5:00pm) for riverside exploration, canoe and kayak experiences, birdwatching and organized research and educational programs.
